Reggie Wilkes is a legendary linebacker who spent a decade playing in the NFL. He was inducted into the Georgia Tech Hall of Fame in 1989, and was later inducted into the Georgia Sports Hall of Fame in 2013. Wilkes is also a member of the NFL Alumni Association and a NFLPA Registered Player Financial Advisor.

After his retirement from professional football, Wilkes knew the next career path he wanted to pursue.
